



BOOK PUBLISHING AGREEMENT

This Agreement is made and entered into by and between **Mr Esmail Nooriala ("Author")** and **Publication, Ltd ("Publisher")** in connection with the publication of Author's book entitled "موانع فرهنگی" ("the Work").

1. GRANT OF RIGHTS

You hereby grant Mehri Publication licence to the exclusive world rights to produce, publish, and sell all editions of the Work in Persian (including in digital format Ebook), to be distributed worldwide by Mehri Publication. You also grant us the right to license the following subsidiary rights: second serial rights; quotations; book clubs; photocopying and other forms of electronic reproduction, translation rights, foreign rights or trade rights in book form. You agree that Mehri Publication has the right to reprint additional copies, when it is deemed by Mehri Publication to be appropriate to do so. Failure to keep this publication in print shall result in the automatic reversion of these rights to the Author, without prejudice to those under a current sub-licence, and at which time the Publisher shall not renew or enter into new sub-licences for the Work. Each revised edition of this book would require a new, signed contract.

2. WARRANTIES AND INDEMNITIES

You guarantee to Mehri Publication that the Work is an original work and has not heretofore been published in whole or in part in book or journal form; that subject to necessary permissions being obtained for material attributed to other persons, does not violate any copyright belonging to any other party; and that to the best of your knowledge, contains nothing of a libellous or objectionable character. If permission from others is required for publication of any copyrighted material contained in the Work, you agree to obtain such permissions at your own expense. You hereby undertake and agree that in the event a claim is brought against Mehri Publication, the Publisher, and/or you as the Author of the Work, that the Publisher will defend both the Publisher and Author in consultation with the Author. If there is a judgment awarded against the Publisher or Author as a result of the Author's breach of this warranty, the Author will reimburse the Publisher for all reasonable legal costs and any judgment, cost or settlement, within a reasonable time frame.

3. CORRECTION OF PROOFS

We will furnish you with one set of galleys or proofs; you agree to correct and return such proofs to us within twenty (20) working days of receipt by you. We guarantee that the Work will, unless prevented by the lack of sufficient publication subvention or other conditions beyond its control, be in print within Six (6) months of receipt of the final manuscript which has been revised to meet the conditions established by Mehri Publication. If after fifteen (15) working days, the Publisher does not inform the Author that the revised manuscript is unacceptable, the revised manuscript is to be taken as acceptable. No changes will be made to the manuscript without your approval.

4. MANNER OF PUBLICATION

The Publisher will make all final decisions concerning the interior design of the book and its cover. The Publisher, at its discretion, has the right to publish the Work with the other publisher name, in this case all conditions will remain in force and the author's account party is still Mehri Publication. Publication will reserve its right for offering a free pdf copy of the Work on its website after six (6) months of the Work's publication date.

5. COPYRIGHT

You will retain exclusive copyright to *Mehri Publication* and a copyright notice indicating this will be printed in every copy of the book. To protect Author's rights, Publisher shall clearly indicate on a single line on the copyright page © copyright mark, the date of publication, and the name specified by Author.

6. PROMOTION AND REVIEW COPIES

Mehri Publication will, in addition to publishing the Work, do the following: (a) Publicise work and promote sales of the work. Such publicity and sale shall be at the sole discretion and within the control of Mehri Publication. You agree that Mehri Publication should be free to offer copies of the Work for sale at discounted and remaindered prices. You also agree that Mehri Publication shall have the right to reprint additional copies, when deemed appropriate by Mehri Publication to do so. (b) Furnish up to five (5) copies for review purposes to journals and critics. Mehri Publication will dispatch other review copies to appropriate reviewing bodies. (c) Furnish up to six (6) copies to the British Library.

7. AUTHOR'S PROMOTION OF WORK

You are free and encouraged to additionally Publicise and promote the sale of the Work through readings, interviews, mailings, your personal web page and any other means you think appropriate. The author has the right to post a 1000-word excerpt of the Work on his personal website/blog, and/or his agent's site.

8. AUTHOR'S COPIES

Mehri Publication will supply you with two (2) complimentary copies of the Work on publication and you shall be entitled to purchase further copies for your personal use at a discount of twenty-five per cent (25%) from the Catalogue Price of the Work in trade paper (exclusive of all applicable taxes). The Publisher shall have the power of discretion from time to time to alter the Catalogue Price of the first or any edition. The postage fee of the Work is payable by the Author.

9. ROYALTIES

The Work is available in a print-on-demand format, and the Author will receive royalties on copies of the Work sold by the publishers or made available for pay in digital form. Royalties shall be paid as follows: ten per cent (10%) for copies of the work sold. No royalty will be paid on free copies furnished to you, or on free copies for review, sales promotion, etc., or on copies destroyed by fire, water, in transit, etc., or on copies sold at below cost.

10. ROYALTIES ON EBOOKS

Royalties for Ebooks and digital format books shall be paid as follows: ten per cent (10%) of net.

11. STATEMENT AND INSPECTION OF ACCOUNTS

An account of the sales of the Work will be made up every twelve (12) months and a report will be sent to you as well. If in any one (1) year period the total payment due to you is less than ten pounds (£10.00), the publisher may defer the mailing of a statement and payment until the payment due totals ten pounds (£10.00) or more. Royalty will be paid within 3 months thereof.

12. MULTIMEDIA RIGHTS

You agree that the rights granted to Mehri Publication under this agreement include all “multimedia rights” in and to the Work, namely the rights:(a) to store, retrieve, display, perform, communicate, distribute, and market the verbatim text of the Work and any translations thereof: —in whole or in part (including abridged versions)—by any electronic, digital, or analogous means now or hereafter known, including but not limited to any wire, radio, visual, optical, or other electromagnetic system, and accompanied or not by and interpolated or not with additional text, graphics, audio or audio-visual elements or works; provided that such accompaniment and/or interpolation shall be subjected to the approval of the Author (which shall not be unreasonably withheld); and (b) to reproduce and otherwise use and exploit, by any means now or hereafter known, the results and products of the exercise of the above rights; provided that “multimedia rights” shall exclude hard-copy print rights other than the rights under this Agreement in association with other works, goods, services, products or institutions.

13. SUBSIDIARY RIGHTS

Mehri Publication shall arrange for any and all subsidiary rights for a licensing fee to be negotiated by Mehri Publication. No agreement will be made concerning subsidiary rights without your approval. Copies of the licenses will be provided to the author.

14. TRANSLATION AND FOREIGN RIGHTS

With respect to translation and foreign rights, if the sale of these rights is initiated by the Author or the Author’s Agent, the Author will retain ninety (90) percent and Mehri Publication will retain ten (10) percent of the negotiated fee. If translation and/or foreign rights sales are initiated by the Publisher, the Author will retain eighty (percent) and Mehri Publication will retain twenty (20) percent of the negotiated fee for the sale of the rights.

15. MOTION PICTURE, TELEVISION, AND VIDEO RIGHTS

With respect to motion picture, television and video rights, you will retain eighty (80) percent and Mehri Publication and Education will retain twenty (20) percent, if these rights are sold by the Publisher. In the event motion picture, television, and video rights are sold by the Author or the Author’s Agent, the Author will retain ninety (90) percent and Mehri Publication and Education will retain ten (10) percent of the negotiated fee for the sale of the rights. In the event of subsidiary rights not specified, Publisher and Author each will retain fifty (50) percent of the fee from the sale of those rights.

16. PERFORMANCE RIGHTS

You retain all radio broadcasting rights, live stage and other dramatic or performance rights. You retain all commercial and merchandising rights.

17. FAILURE TO PUBLISH

If Mehri Publication fails to publish the Work and has sold licenses to the Work, all rights to the Work automatically revert to the Author and all the licenses will be assigned directly to you, and Mehri Publication will no longer be entitled to any revenue from such licenses.

18. REPROGRAPHIC RIGHTS

Notwithstanding any other provision of this Agreement, the Author and Publisher agree that: (a) either or both of them may license to ACCESS Copyright, on behalf of both Author and Publisher for their mutual benefit to i) administer photocopying and other reprographic rights in the Work, and ii) authorize copying by means of electronic database storage and retrieval; (b) ACCESS Copyright shall make royalty payments in respect to the Work in accordance with the rules of ACCESS Copyright, i) directly to both Author and Publisher, if the Author is an ACCESS Copyright affiliate, or ii) if the Author chooses not to become an ACCESS Copyright affiliate, you agree that any accruing royalties paid to the Publisher by ACCESS Copyright will be used by the Publisher to promote the Work.

19. REQUESTS FOR INFORMATION

You agree to furnish any and all necessary data for cataloguing the Work and promoting its sales and are requested to assist Mehri Publication in obtaining access to mailing lists and to any other information that would facilitate the promotion of the Work.

20. DURATION OF THE AGREEMENT

The term of this Agreement shall be for three (3) years. This Agreement shall automatically be extended at the end of those three (3) years and shall continue indefinitely until and unless a party act as stated in paragraph 21 and 22.

21. TERMINATION OF THE AGREEMENT BY THE PUBLISHER

At any time after three (3) years from the date of the original publication, Mehri Publication may cancel this contract under the following terms and conditions: (a) Mehri Publication shall give the Author one (1) month's notice of such cancellation by letter to the Author's last known address. (b) On receipt of such notice the Author shall have the right to purchase from Mehri Publication, at cost of the original production, the plates of the text of the work if such plates are in existence and at the disposal of Mehri Publication. It is understood that the cost of original production of the text plates shall include the cost of typesetting. Upon such termination of this Agreement, all rights automatically revert to the Author.

22. TERMINATION OF THE AGREEMENT BY THE AUTHOR

You may terminate this agreement by written notice to the publisher, under the following circumstances, whereupon all rights in the Work shall revert to you as the Author of the Work: **a)** failure to publish in the specified time whether that failure arises from insufficient publisher subvention or for any other reason; **(b)** if the Work is out of print; if the Publisher fails to list the Work in the Publisher's marketing material and has no copies of the Work available for sale, and after written or email request from the Author, fails to reprint the Work within six (6) months; **(c)** if the Publisher defaults in payment and neglects to pay any monies owing when due and payable for a period of three (3) months after written or email demand from the Author. Reversion of these rights does not prejudice Author's right to receive payment from any outstanding licenses. **(d)** Should the Author decide to terminate the agreement before the end of three years, a minimum compensation fee of £1000 will be charged to cover the expenses incurred by the Publisher for administrative, marketing and other related activities.

23. BANKRUPTCY AND INSOLVENCY

In the event of bankruptcy, receivership, or assignment for the benefit of creditors, or liquidation of the Publisher, all rights shall revert automatically to the Author and the Author shall be entitled to all plates, all reprographic material, and sheets and copies at their fair market value.

24. PUBLICATION GRANTS

In the event that a grant or a subsidy related to this publication is or will be available to the publisher, and irrespective of who has obtained such grant or subsidy, you shall relinquish any and all claims to the grant or subsidy, in favour of Mehri Publication, immediately upon receiving written notice from Mehri Publication, that it will proceed with publication. This clause does not apply to grants or awards available to writers.

25. INDEMNIFICATION OF INANNA

It is understood and agreed that Mehri Publication is not an insurer of manuscripts, drawings, photographs, and sheets placed in its possession and will not be liable for the loss thereof.

26. INTERPRETATION

This agreement, which shall be construed in accordance with the laws of England, regardless of your place of residence, contains the entire agreement between you and us concerning the Work and shall inure to the benefit of and be binding upon your heirs, executors, administrators, or assigns and Successors or assigns of Mehri Publication. This agreement may not be assigned by either party without the prior written consent of both the Publisher and the Author.

27. ARBITRATION

Should differences arise between the Author and the Publisher concerning the meaning of any terms of this Agreement or the rights and liabilities of the parties hereunder, the matter shall be referred to the arbitration of two persons (one to be named by each party). The costs of such arbitration shall be shared equally between Author and Publisher.
